3. Only individual membership will be accepted and membership is nontrasferable. The Bharat Swabhiman (Nyas) will be free to take any decision on the application of the natural heir of a member for the transfer of membership of him/her on the demise of the concerned member. In the event of membership by an institution, only a person, according to the laws of that particular institution, or a person nominated by that particular Institution may attain benefits of membership of Bharat Swabhiman (Nyas).

The membership is restricted to individuals (persons/institutions) who undertake and agree to follow, observe and put into action the main objectives of the Bharat Swabhiman (Nyas) which seeks to make life (a) spiritually rich (b) physically healthy and (c) mentally sound by use of Ashtang Yog and ancient medical science of Ayurved as well as generating patriotism among countrymen.
